Social contract

Students are required to complete four micro-essays (750 words each; single spaced) and one analytical essay (5-7 pages, double spaced). Your micro-essays should be single-spaced and printed on both sides of a single sheet of paper. The final exam will consist of seven micro-essay questions, which students will see before the exam. Four of the questions will be selected at random on the morning of the exam. All assignments and the final exam will be posted on my HOMEPAGE: on the menu page, below the list of classes, click on ASSIGNMENTS.

The weight of each assignment is as follows:

40% micro-essays (10% each) 20% presentation/democratic breakdown essay (5% and 15% respectively) 25% final exam 15% class participation (debates, three questions, etc.)

No student who misses as many as **eight** class sessions, for whatever reasons, shall receive a passing grade. After three absences, a student's class participation grade will begin to be reduced for each additional absence.
