Brooke Bailey Named to all-CCIW Second Team

BLOOMINGTON, Ill. — Illinois Wesleyan senior Brooke Bailey has been chosen to the second team of the all-College Conference of Illinois and Wisconsin women's basketball squads in voting today by league coaches.

Bailey, a 5-foot-11 forward from **Byron (HS)**, was a third team selection last season and is IWU's lone representative this season.

Bailey finished third in the conference statistics in scoring with a 13.9 average, fifth in rebounds (6.7), ninth in field goal percentage (.436) and led the conference in 3-point field goal accuracy (.400, 22 of 55). She connected on 1.67 3-pointers and blocked .79 shots per game, both sixth among league players.

Wheaton senior guard Sarah Clark and head coach Beth Baker were chosen as the CCIW's top player and coach, respectively.
