## PHILOSOPHY

Philosophers try to make sense of human experience through critical reflection and argument. The study of philosophy involves asking questions about the nature of knowledge, reality, and values, and formulating and evaluating answers to these questions. As a philosophy major or minor at Illinois Wesleyan University, you will be introduced to various traditional philosophical issues such as the nature of consciousness, personal identity, the nature of morality, and skepticism. Your understanding of these issues will be strengthened by reading the works of major philosophers, including Plato, Descartes, Hume, Kant, and more recent figures.

### Why Philosophy at Illinois Wesleyan?

- Philosophy classes typically have no more than 25 students.
- Frequent papers and other writing assignments enable students to polish their critical analysis and communication skills.
- The philosophy faculty is committed to working closely with students and answering their questions in and out of class.
- A high percentage of philosophy majors also pursue a major in another discipline. If you are interested in a double major with philosophy, the faculty will work with you to tailor your philosophy courses to your other disciplinary interest.
- Philosophy is recommended as one of the best preparations for the GRE and LSAT examinations.
- Recent philosophy students have been admitted to graduate and professional programs at such prestigious institutions as Stanford University, Harvard University, University of North Carolina, University of Minnesota, MIT, University of Michigan, University of Colorado, University of California-Irvine, University of Michigan Law School and Yale Law School.

### Putting Learning into Practice

- **Independent Study:** In the last several years, philosophy students have explored areas outside the regular curriculum through projects on topics such as medical paternalism, skepticism, and reductionism.
- **Research Honors:** Students may pursue a project of original research in philosophy. Typically, after spending a semester of independent study during the junior year reading books and articles relevant to their research area and honing their thesis topics, students write their research thesis during the Fall term of their senior year. In recent years, students have written on topics such as intentionality, the nature of consciousness, and justice.
- **Internships:** Students have held positions at the Hastings Center (a medical ethics think-tank), the U.S. State Department in Washington, a New York City publishing firm, and the Muscular Dystrophy Association in Chicago.
- **Study Abroad:** Many philosophy majors elect to gain the invaluable experience of living and learning in a different cultural setting. In recent years, students have studied at Pembroke College at Oxford University, King's College in London, and in Ireland at Cork University. Recently, several majors have studied in Copenhagen, Denmark.
- **Philosophy Club:** The Philosophy Club shows films, sponsors debates, and hosts and attends speakers series. They also host a weekly lunch, which enables philosophy faculty and students to discuss philosophical issues and upcoming events.
- **Ethics Bowl:** The Ethics Bowl is an intercollegiate team competition focused on cases that explore a variety of ethical issues, including freedom of speech, our treatment of the environment, and racial and gender equality.
