Reproductions are provided for research purposes and do not imply permission to publish in any format.*

Please note that pre-payment is required before requests can be processed and a valid email address for the requestor must be provided. All fees for research and reproductions go towards maintaining archival collections. Payments may be made in cash or checks made out to The Ames Library, Illinois Wesleyan University.

Scans (includes equipment set up time and up to 5 images; \$1 for each additional)

Existing digital image (at low resolution)	Free
New or re-scan at higher resolutions - original item no larger than 12 x 17 in. @ 600 dpi	\$10.00
New scan - oversize item larger than 12 x 17 in. @ 400 dpi	\$20.00

Delivery method is by email attachment or temporary link for downloading scanned materials from the web. Patrons are responsible for downloading and saving copies within the time limit specified on delivery.

For scans burned to a CD, there is an additional charge of \$5.00.

All scans are completed by the archives staff. On-site patrons may use personal cameras for duplication after seeking approval from the archivist. The archivist reserves the right to deny duplication of materials.

RESEARCH AND OTHER FEES

For all orders placed remotely, a labor charge of \$20 per hour is added to requests that require more than 1 hour for research and reproduction.

For delivery by mail, shipping and handling rates will apply.

Standard service completion time is 10 business days.

Expedited requests (including one-day rush) may be possible but will incur additional costs.
